NOL informed the meeting that SL had resigned as staff governor and the governing body had removed SMcH and JC as their posts were no longer current. NOL proposed that the governing body appointed SMcH, SL and JC for the positions of Co-opted Governors. 5.0 Head Teachers Report (on VLE)

NLF reviewed his report for Governors present highlighting the following points;

- He had discussed school not going over 420 pupils with LA. The conclusion of this was that it would only be considered with reference to Health and Safety issues.
- AB asked if it was only Year 4 that would have the very high numbers, NLF confirmed this, SL commented that the high numbers could potentially cause health and safety issues in the playground and hall areas due to the size.
- NLF advised the Governors that all children in school have achieved excellent levels for example; 60% have achieved level 4 and 18% level 5 in year 6 maths.
- NLF confirmed that our value added figure is 102 adding that this is pretty good and he would be reviewing this data again in September to further advise Governors on the most recent data. AB commented that we had been expecting good results. NLF agreed but added that we have had several new children whose achievements had come on in leaps and bounds since joining St Bridget's so we are not coasting.
- NLF advised Governors that Y1 had been struggling a bit in phonics however, KH worked tirelessly on this and we are now achieving better than the national average. NLF thanked KH for her hard work and commitment
- NLF confirmed that there has been a significant amount of staff training
- Clubs and curriculum enrichment were continually on our twitter feed on the school website, Governors could also keep up to date on some of the things we do on a regular basis if they follow twitter. NLF also advised the Governors that Miss Bowler had just achieved the silver mark for sports, and thanked her for her commitment and hard work
- NLF also brought to the attention of Governors the September classes and confirmed that parents have been informed
- This week is transition week for all children and year 6 are visiting their new senior schools tomorrow

Further comments from Governors present ;

- NOL commented that he found the breakdown of vulnerable groups very helpful, and asked if that existing information could remain on the report for future issues as a timeline.
- JC asked if NLF could pass on Governors thanks to Miss Bowler her amazing achievements with sports in school

	NOL asked the Chair SL if there was anything significant needed to be reported by the Committee	
	SL was pleased to advise the meeting that school has a Healthy budget and she wished to thank the Bursar and Headteacher for their commitment to this, she further commented that this was especially important in view of increases in National Insurance and teachers' pension contributions of circa £55,000 which had been completely unexpected. SL further commented that without the careful management by the Bursar and Headteacher the school would have gone over budget.	
	NOL added that at the beginning of the 2014/15 year we had brought forward reserves of £69k and we ended that year with carried forward reserves of £121K which meant that we had had a surplus for that year of £52K. The budget for the 2015/16 however currently shows a budgeted deficit of £31K although it is likely that the deficit will not in due course be quite that big. As a result the budgeted carried forward reserve at 31 March 2016 is £91K. In addition to the above we also have formula capital brought forward of £28K to spend in the 2015/16 year.

	• NLF commented that many schools had reconstituted with a much smaller Governorship to avoid non-attendance, whereas St Bridget's had opted to stay at a similar size.	
	• SD raised the point that Skype might be an option, although it was considered a possible problem with confidentiality
